Frequently Asked Questions About the Cancellation Process for the 2020 International Convention

Q: Will my registration be refunded?

A: Yes, registration fees will be refunded in full within 6 weeks. The \$5 cancellation fee will not be charged. We ask for your patience and request that you not call the registration company directly until at least 6 weeks have passed to allow time for refunds to be processed.

Credit Cards: If you paid with a credit card, that card will be credited directly. If you no longer have the credit card used during registration, you will be refunded by check.

Checks/Money Orders: If you paid with a check or money order, a refund check will be processed and mailed to your address.

If you canceled your registration and were charged the \$5 cancellation fee, the charge will be refunded to you.

Q: Will my hotel reservation be canceled and deposit refunded?

A: Yes, your reservation will be canceled by the Housing Bureau and you will receive a confirmation of the cancellation. If the hotel has charged their deposit, you should receive a refund of the full deposit by April 30, 2020. If you do not receive your refund by April 30, 2020, please contact the hotel directly. Their phone number is listed on your hotel confirmation email. If you need additional support, please email **2020ichousing@sxsw.com** or call 1-512-872 -2159.

Q: What about my airfare?

A: Please contact your airline carrier about canceling your ticket.

Q: I rented a scooter or wheelchair, will that reservation be canceled and refunded?

A: Yes, your reservation will be canceled and refunded within 8-10 weeks.

Q: I signed up to be a volunteer. Do I need to do anything about the shifts I signed up for? A: No, all shifts will be canceled.

Q: Were all 2020 International Convention ancillary events slated to take place in Detroit canceled?

A: All events scheduled as part of the agenda of the International Convention have been canceled including the Al-Anon portion of the International Convention and the Thursday evening Party in the Plaza.

Q: What happens to the souvenir book I purchased?

A: If you purchased one or more souvenir books while registering, the credit will be added to your total refund.

Q: What happens to the subscription I purchased?

A: If you purchased a subscription while registering, the subscription has been processed and you should already be receiving *Grapevine* or *La Viña* magazine.



Step 5 is a beautiful step to me. When I took this with full honesty, I was able to feel freedom.

My first two years of Sobriety were hard on me with the constant thought of drinking crossing my mind daily. I was one who, in the beginning, got a sponsor right away and started working on the steps. I participated in multiple service positions with my group and once fully finished with the steps, started sponsoring. Even with doing all of this, the thought of drinking would still cross my mind. Everyone would talk about how their craving for alcohol had gone away. I questioned myself all the time as to why I was still suffering with this.

At two years sober, I started a new journey with a new sponsor. She, of course, started me at the beginning of my steps. We moved at a slower pace and she took me through each step thoroughly. By the time step four came, I felt safe and could trust this woman. While doing step 4, I questioned myself on putting this one thing down on paper to share with her. I had this idea that sharing it with God was enough, I mean, he knows everything about me already, right? If he could forgive me that was all that mattered to me.

I sat with my sponsor and we started my step 5. Once I finished, she asked me if there was anything else. I told her no, knowing that I was still hiding something. A few days later, the thought that I was hiding something continued to cross my mind. I called her and told her I had one more thing that was not on my step four. We sat down and I told her of this one thing that made me think of myself as a horrible human. I believed I would be shunned out of AA if anyone knew. Exactly the opposite happened, she embraced me, and accepted me for who I was. That was the first night I got a peaceful night sleep for as long as I could remember. I truly felt free.



Throughout our world services structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered.

The third of our three "rights" laid out in our <u>Twelve Concepts for World Service</u>, the Right of Appeal is about making every effort possible to hear all opinions on whatever issue is before the group.

It's about hearing all the voices.

But how do we draw out those voices? It's easy for some of us who have been around a while and are firm in their opinions (maybe too firm, but that's a Tradition Two discussion). Some of us have naturally loud voices. But what about the quieter member or the one who routinely sits at the back of the room? Theirs may be just the opinion we need to hear.

Concept V asks us to find ways to encourage these voices. One suggested way is to conduct a sharing session (see "SMF-111 How to Conduct a Sharing Session" from aa.org). This type of roundtable discussion is an excellent way to draw out various opinions in a non-judgmental way – and you may hear something that will change your mind! This, to me, is when A.A. is at its best. I have been astonished to hear real insight come from all levels of service experience and sobriety. You never know who your Higher Power will use to carry the message!

A GUIDE TO BEST PRACTICES FOR A DIGITAL 7TH TRADITION

Online meeting spaces make it difficult to "pass the basket." Some groups have set up digital contribution accounts with services like Venmo, PayPal, Google Pay, etc. to deal with this problem. Now might be a good time to review an essential piece of AA literature, "Self-Support: Where Money and Spirituality Mix." Each group is autonomous and might consider taking a group conscience on whether digital contributions are an option, and which platform (or mix of platforms) best suits their groups' needs. But first, why collect 7th Tradition for an online meeting?

Our regular meeting locations still have operating expenses...

Our meetings facilities may rely on our regular rent to help pay their rent, utilities, and employees Meeting supplies will still be needed when our meetings reopen – coffee, paper products, literature, refreshments. And after an extended closure, we may experience a large influx of people who are motivated to re-join the fellowship in person.

Central Office and the General Service Office still have operating expenses such as...

- Websites which we may now rely on more than ever!
- Phone lines, rent and insurance on office space
- Utility and other ongoing expenses

Paid Special Workers who deserve our continued support. Their compensation is crucial to their ability to serve us.

Our Districts and Areas and H&I still have expenses

Regular expenses to support the work of committees and events that will take place when the crisis has passed are still there.

Web services support for groups

Expenses for venues for events that have been cancelled may still need to be met, since any income from the event won't be there to support the pre-payment of reservations, cancellation fees, etc. The expense of re-arranging for venues to reschedule events is very real.

Let's continue to support these folks during the crisis.

We realize that even though the immediate need for virtual connections is relatively inexpensive, the real expenses of our fellowship continues. Please consider continuing to practice our 7th Tradition and make contributions to the service entities that support your group.


