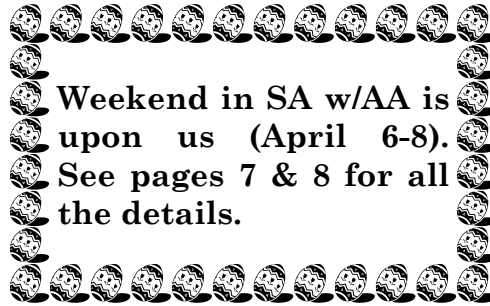

*It is with great sadness that we share the news that Nell Wing died on Wednesday, February 14, 2007 at 7:00pm after a lengthy illness. Nell was 89 years old.*

*Nell was Bill W's secretary and assistant for 17 years and a close friend and long-time companion to Lois W. She worked at the General Service Office of A.A. from the beginning of 1947 until her retirement at the close of 1982, starting as a receptionist and later becoming secretary of A.A. World Services, Inc. Additionally, she served as G.S.O.'s first archivist for the last ten of her years at the office. The Archives opened in 1975.*

*From "Markings", November/December 1983, when Nell announced her retirement in print: "...I hope to stay nearby; and never lessen interest in this fellowship, nor loosen the close bonds of friendship with my A.A. and Al-Anon friends. I'm forever grateful for this marvelous experience that began for me on March 3, 1947, at 415 Lexington Ave., New York City, in 3 small rooms of the Central Terminal building. I have enjoyed and treasured every moment of it. I won't say 'goodbye;' just want to extend my love and thanks to each one of you dear friends.".....*

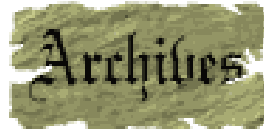
## CSO Archives<sup>1</sup>

“History,” wrote Thomas Carlyle, (1795 –1881), [Scottish](#) essayist, satirist, and historian, “is the essence of innumerable biographies.”

Perhaps nothing better sums up A.A. history better than the millions of personal stories of recovery that come together as a priceless legacy in the A.A. Archives. CSO’s new book, “AA in SA,” written by our own Bob R., is a wonderful subset of these colorful and drab, dynamic and mundane, sometimes hilarious and sometimes tragic, stories of the larger, national, experience. These stories help make up San Antonio Metropolitan Area’s history; and the preservation and making them accessible is the reason for the CSO Archives Committee’s existence. Again, this is why we have the CSO Archives Committee.

Like any other A.A. service work, the primary purpose of those involved in archival work is to carry the message of Alcoholics Anonymous. The collective experience of the past reminds us of how little hope there once was in South Central Texas and San Antonio for the suffering alcoholic—of how far we’ve come, thanks to Alcoholics Anonymous here. And as we painstakingly sort out fact from fiction, we ensure that our original message of recovery, unity and service will continue undiluted and true.

Archival service work is more than mere custodial activity; it is the means by which we collect, preserve and share the rich and meaningful heritage of our Fellowship area. It is by the collection and sharing of our area’s historical elements that our collective gratitude for Alcoholics Anonymous is deepened. Correspondence, records, photographs, the past need to be collected, preserved and made available for the guidance and research of A.A. members and others, and the generations to come.



How can you help? There are many ways to participate in this rewarding aspect of AA service. Think of donating anything from any activity that may interest a future member or researcher. If you know old-timers, ask to tape their stories of the past. You can volunteer time to sort through donated material and help organize files. Currently, we have a need for folks to simply remove staples and begin the process of organizing our Board’s minutes. If you are interested in any aspect of archives, from helping to just looking, please let us know. We’d like to hear from you!
