# Where Our Money Goes—How to Read the Financial Report

*Idea taken from The Messenger, 02/08 issue, Nashville, TN*

Every month, we publish a report on the status of the Central Service Office (CSO) finances on page 5 (sometimes an insert) of The Nightcap. We do this because we want those who contribute to the office to know exactly what their contributions pay for. This is itemized in the Profit and Loss Statement. Trouble is, a lot of people don't understand the report! So here, we explain item by item, what the statement of activities contains.

## PART I: INCOME

### A. Contributions

1. Birthdays: Individuals contributing yearly during their AA sobriety month. Some will give \$1 per year, some will contribute \$1 per month.

2. Group: These contributions come from our groups' 7th Tradition distribution. Each group gives according to their group conscience decision. A breakdown of these group contributions is reported on the back side of the financial statement in The Nightcap.

3. Individual: A total of contributions from the Office Kitty, Board Meeting, and/or individual AA members. Each individual AA member may give a maximum of \$3000.00 per year which is tax deductible.

4. Memorial: On occasion an individual AA member may want to contribute to CSO in memory of a loved one or friend who has passed away. We accept these, and all, contributions from AA members only.

**B. Nightcap Income**—Money received for The Nightcap subscriptions.

### C. Sales Income

1. Gift Certificate Sales: Money received from the purchase of gift certificates.

2. Sales Item—AA: Total amount of money collected for the month/year for Conference-Approved AAWS and Grapevine literature.

3. Sales Items—Miscellaneous: Total amount of money collected for the month/year for gift items and non-AA books, etc.

4. Sales Income-Copies: Money collected for making copies for groups/individuals at \$.04 per page.

**D. Shipping**—Money collected for shipping merchandise.

**E. Total Income**—Total of all above.

**F. Total COGS**—Minus the total cost of goods sold.

**G. Cost of copies, paper**—Minus the cost of making copies at \$.0185 per copy.

**H. Purchases Discount**—Minus a 20% discount given on the sale of hard back (B-01) and soft back (B-30) Big Books when purchasing 20 or more.

**I. Gross Income**—Total amount the office collected for the month, not counting expenses.

## PART II: EXPENSE

**A. Advertising/Publicity**—Currently this item is for Yellow Page advertising for Alcoholics Anonymous.

**B. Archives**—Materials needed to preserve historical material at CSO.

**C. Communications**—Phone lines, including call forwarding, call waiting, call notes, DSL, web hosting.

**D. Contract Labor**—Money paid to occasional workers who fill in when the regular employees need extra help (i.e., when one or the other regular employees is on sick leave or vacation).

**E. Credit Card & Bank Fees**—Fees paid for the use of credit cards and terminal fees, we currently have no bank fees.

**F. Depreciation Expense**—An accounting/tax category accountants use to value our office equipment.

**G. Equip/Furn/Display/Small**—Purchase of small equip or displays for furniture, like adding machines, etc.

**H. Insurance**—Premiums for property insurance.

**I. Membership**—Sam's Club

**J. Miscellaneous**—Rare expenses that are out of the ordinary and fully explained at the Central Office Representatives (CORs) meeting.

**K. Nightcap—Printing & Postage**—Cost of printing and mailing of our monthly newsletter.

**L. Salary Expense**—Money paid to the office manager, administrative assistance and clerk in salaries.

**M. Payroll Expenses—Other**—What we pay Social Security and Medicare for our share of employee salaries.

**N. Postage**—Cost of shipping merchandise.

**O. Professional Fees**—Cost for an accountant to prepare our yearly 990.

**P. Rent**—Rent for our office on Tradeway

**Q. Rent—Equipment & Storage**—Rent for the copier and for our storage space at A-AAA Storage.

**R. Repairs/Maintenance**—What we pay for routine office maintenance, copier, computer repairs, etc.

**S. Supplies—Office**—Cost for non-durable office supplies (paper, ink, mailing materials), and semi-durable supplies (things that can be re-used, like file folders, staplers, scissors, hole punchers, storage file boxes, etc).

**T. Supplies—Other**—Coffee, cleaning supplies, water, sodas, supplies for yearly open house etc.

**U. Taxes—Other**—Currently this is used for property tax owed.

**V. Training**—Registration for Intergroup/Central Office Seminars, also, employees may be taking a CPR class in the future.

**W. Travel**—Expenses reimbursed for attendance at the yearly Intergroup/Central Office Seminar, and once every other year for the manager to attend the Regional Seminar. Employee mileage for office errands.

**X. Utilities**—Electricity and water.

**Y. Volunteer Training/Recognition**—Currently used for thank you gifts at Christmas for office volunteers.

**PART III: NET ORDINARY INCOME**—Difference between Gross Profit and Expenses.

## PART IV: OTHER INCOME/EXPENSE

**A. Interest/Misc Income**—Interest from certificates of deposit and savings account. Any other out of the ordinary income like a refund.

**B. Inventory Adj (gain)** - Inventory taken twice a year, and adjusted if there is a gain.

**C. Inventory Adj (loss)** - Inventory taken twice a year, and adjusted if there is a loss.

**D. Lit—AA Community Support**—Literature given away to groups or service committees usually in an attempt to rotate stock.

**PART V: NET OPERATING INCOME**—Total of all office income minus expenses, with the exception of the funds from Weekend in SA.

**A. Weekend in SA - Income**—Income for the year from the Weekend in SA Conference.

**B. Weekend in SA—Expenses**—Reported expenses for the year from the Weekend in SA Conference.

**PART VI: NET INCOME**—The difference (plus or minus) between our expenses and our income.

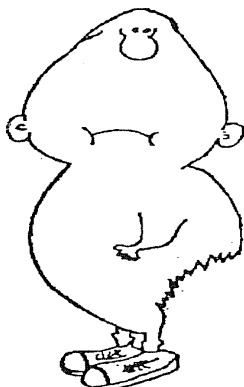

## WHAT IS A COR AND WHY DOES MY GROUP NEED ONE?

The Central Office Representatives (CORs) are at the very core of the structure of the Central Service Office (CSO). Each AA group within the San Antonio Metro Area may elect a member to serve as the group's COR. Through the COR monthly meetings, the groups are kept informed of office activities and allows the COR to voice opinions and or inquiries of his/her group.

The CORs oversee the actions of the Board of Trustees of CSO, and have the right to override any Board decision. Amendment/change to the CSO bylaws proposed by the Board of Trustees are made available to the CORs at the COR meeting which follows the initial presentation of the amendment/change by no more than sixty (60) days, and must be ratified by a vote of two-thirds of the voting members present at the COR meeting.

The COR serves as a vital link in maintaining two-way communication between the group and CSO. The COR takes the responsibility for keeping the group informed on CSO matters, and provides CSO with up-dated information of a group contact name and phone number. The COR keeps CSO advised of any meeting changes, additions, etc, of their group.

CORs remind their group that the CSO's purpose is to serve the AA groups of the community, and that financial contributions to the CSO are voluntary and not a condition to receive this service.

The COR provides their group with a summary of functions/services of the Central Office and explains how it is staffed and operated. A list of these functions/services are available at the Central Office.

The COR encourages membership in the CSO Outreach Committee, which does group visitation to help other groups without representation to see the need. The Outreach Committee also encourages members to subscribe to The Nightcap, volunteer for the 12-Step list of people willing to carry the message of Alcoholics Anonymous, and serve as an after-hours phone volunteers.

The term of office for a group COR is two (2) years; however, each group may determine the term of office for it's representative. Each group may also elect an alternate COR. All AA members are welcome at a COR meeting.

Without representation from your group, the CSO will operate from the decisions of only a few. This is not the AA way. If you need to be more informed, call your CSO anytime during business hours and we will try to answer your questions. Please search your group conscience, and we hope you will send your voice to the next COR meeting. The CORs meet the 3rd Monday each month at 6pm. Call CSO at 821-6325 for the location and directions.

We are so fortunate to have a CSO in San Antonio. It is the responsibility of every AA member to protect the integrity of the office. You can do this through a COR.

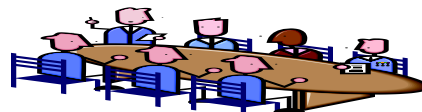

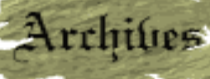

- *Receive, classify and index all relevant material, such as administrative files and records, correspondence, and literary and artifactual works considered to have historical import to Alcoholics Anonymous.*
- *Hold and preserve such material.*
- *Provide access as determined by the archivist in consultation with the trusts' Archives Committee, to members of Alcoholics Anonymous and to those of the public who may have a valid need to review such material with access to be provided only during business hours and with a mindful view toward the anonymity of our members.*
