History of the AA Grapevine

The *Grapevine* was created by six AA members in the New York area—four women and two men. With the blessings of AA's co-founder, Bill W, they published the first issue in June 1944, just nine years after the founding of AA. A copy of that first issue was sent to every AA Group—about 300 at the time—and to all known AA members in the armed services overseas. An entire page with the heading, "Mail Call for All AAs in the Armed Forces," was devoted to letters from these members, who began calling the *Grapevine* their "meeting in print." The title stuck, and today the *Grapevine* and LaViña carry it on their covers.

Grapevine's yearly subscription is \$27 for 1 year; we are encouraging all Groups to buy a one year subscription for their Group clipboard and at the end of the year collect all old issues and bring them to the Grapevine Rep at the monthly SAMSO meeting. But Don't AA Groups Use the Lord's Prayer?

The practice of ending meetings with the Lord's Prayer, once almost universal, is still common in many areas. Where it still exists, the leader normally asks attendees to join in only if they choose to. North American groups today have found a variety of ways to close their meetings. Use of the Lord's Prayer is rare in Spanish groups in the US, and groups outside the United States. Many recite the Serenity Prayer or AA's Responsibility Statement; others use some other informal prayer or phrasing, or simply a moment of silence. And whatever the specific wording, the group conscience makes the decision.

Groups that continue to close with the Lord's Prayer are following a custom established in the Fellowship's earliest days, when many of the founding members found their support in meetings of the Oxford Groups. The practice of closing with the Lord's Prayer very likely came directly from those meetings. At the time, there was no AA literature, and so the founders leaned heavily on Bible readings for inspiration and guidance. They probably closed with the Lord's Prayer because, as Bill W explained, "it did not put speakers to the task, embarrassing to many, of composing prayers of their own." Meeting formats became more inclusive once AA began to spread throughout North America and then the rest of the world, and it became obvious that the program of recovery could cross all barriers of creed, race, and religion.

In *Alcoholics Anonymous Comes of Age*, the Rev Samuel Shoemaker, one of the nonalcoholic friends who was instrumental in shaping the Fellowship in the very beginning, reflects on the founders' fundamental decision not to define a set of beliefs. He says (pages 263-64): "AA has been supremely wise, I think, in emphasizing the reality of the experience, and acknowledging that it came from a higher Power than human, and leaving the interpretation part pretty much at that...If AA's had said more, some people would have wanted them to say a great deal more, and define God in a way acceptable and congenial to themselves. It would have taken only two or three groups like this, dissenting from one escapable experience and told people to turn their wills and their lives over to the care of God *as they understood Him*. That left the theory and the theology...to the churches to which people belong. If they belonged to no church and could hold no consistent theory, then they had to give themselves to the God that they saw in other people. That's not a bad way to set in motion the beginnings of a spiritual experience."

A Brief Overview of GSO's eBooks Project

The activities of the General Service Office in support of this undertaking are collectively referred to as the "eBooks Project". This effort is an inter-departmental project of the General Service Office, and will be pursued in phases. The initial phases of the project are as listed below.

<u>Phase 1</u>: This phase is now underway with expected completion targeted for early 4th quarter of 2011. When completed, individuals will be able to purchase the English, French and Spanish versions of the 4th Edition of the Big Book *Alcoholics Anonymous* and the *Twelve Steps and Twelve Traditions*. Purchased copies of these eBooks may be downloaded and read using the *AA Mobile App*, on Apple iPhone / iPod Touch devices and on the Apple iPad, in "compatibility mode". Compatibility mode, a feature that allows Apps designed for the iPhone to run on the iPad, will be available.

<u>Phase 2</u>: This phase, when completed, will allow purchased copies of eBooks to be downloaded and read on most Android powered devices and, various eReaders as appropriate terms are agreed to. Estimated completion of Phase 2 is the 2nd quarter of 2012. <u>What is next</u>? Plans are being made for an eBook presentation to be given to Delegates and all members of the General Service Conference in May 2011. As the project continues to develop, you can expect to receive further communication.
