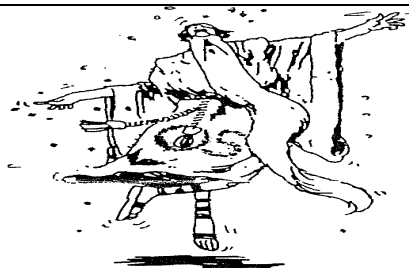

Did you know that each A.A. entity sets its own individual contribution limit, if one is set at all? The \$2,000.00 limit referred to in our literature, the A.A. Service Manual and The A.A. Group pamphlet, refers to GSO only. The San Antonio Central Service Office abides by the limit GSO sets for itself, which is currently \$2,000.00 per member per year. Why? Because it is in our By-Laws to do so, and also CSO does not wish to become the seat of perilous wealth or power as is stated in Concept 12, Warranty One.

Here are statements on this issue provided by two of our trusted servants:

1...The pamphlet, The AA Group, as you know underwent a major rewrite that was approved in 2005. The wording pertaining to contributions to GSO was changed to reflect that the \$2000 dollar limit pertained only to GSO contributions. The General Service does not tell us, the Fellowship, what to do. The office does share AA's experience pertaining to the accumulation of wealth but that is all. The pamphlet now reflects our 4th Tradition pertaining to group autonomy and our freedom as outlined in Warranty Six of Concept 12. It is best that each AA entity determine through its group conscience what is best for itself.

As you know, no one can speak for AA so this is only my humble thoughts pertaining to your question.

2)...The limitation applies ONLY to individual contributions (not group) to the General Service Board, and not the other entities. I believe it has been that way since the first limitation was set in 1966 at \$100. The old Alcoholic Foundation had a limitation as well, but I do not have information on the amount or when it was set up that way, but it was evidently a problem as early as 1941, which is probably when the first limit was set.

As an aside, the individual contributions should be made payable to the General Service Board of Alcoholics Anonymous, Inc. Checks received with other names (like New York Office, GSO, General Service Office, etc.) are endorsed over to the GSB anyway. The GSB is the legal receiver and custodian of AA Group, and individual, contributions.

Any other AA entity (Group, District, Area, Committee, Central/Intergroup office, etc.) is free to set (or not set) their own limits, subject, however, to their bylaws or articles of incorporation, if applicable.

A.A. is a "we" program, and the Central Office Rep (COR) position provides a way for your group to connect with other groups and A.A. as a whole; also, it provides a service opportunity that can lead to more service options for your group.

The San Antonio Metropolitan Service Organization (SAMSO) Guidelines

STATEMENT OF PURPOSE

The purpose of the San Antonio Metropolitan Service Organization (SAMSO) is to carry the AA message through coordination of service activities among the districts in the metropolitan service area in accordance with the Traditions and Concepts for World Service of Alcoholics Anonymous.

MEMBERSHIP

San Antonio DCMs (District Committee Members), the GSRs (General Service Representatives) or Group Representative (in lieu of GSR), and the standing Service Committee Chairs, or their alternates.

OFFICERS

All officers, with the exception of the treasurer, will serve a one-year term. The treasurer will serve a two-year term. A DCM will be selected to serve as Chair. Other positions will be filled by DCMs or GSRs having at least one-year service experience in SAMSO. Officers will be approved by the general SAMSO membership.

SAMSO SERVICE COMMITTEES

Each service committee, subject to approval of the SAMSO membership, will elect the chairperson for that service committee. Service Committee Chairpersons serve a two-year term. The Service Committee Chairperson is to provide a written report to be passed on to the next Chair. New and/or ad hoc committees may be established as the need arises. The currently approved service committees are:

- Archives
- Bilingual
- Correctional Facilities (CFC)
- Grapevine
- Public Information/ Cooperation with Professional Community (PI/CPC)
- Treatment Facilities
- Service Newsletter

The standing Service Committee Chairs will hold periodic meetings. Their committees will consist of volunteers from the AA groups in the SAMSO area and all pertinent committee representatives from each district. The Service Committee Chairs will provide assistance and suggestions for the purpose of creating workshops and organizing the service effort for their committee. All Committee Chairs or their designees will attend and give a report at the monthly SAMSO meeting.

MINUTES and TREASURER'S REPORT

The minutes and the treasurer's report will be approved at the **SAMSO** meeting and printed in the service newsletter.

WORKSHOPS

One (1) workshop a year will be hosted by SAMSO as a whole, preferably in November. The purpose of this workshop will be to promote interest in and provide information and familiarization with SAMSO service committees and all other aspects of service available for San Antonio AA members.

MEETINGS and VOTING

SAMSO will meet on a monthly basis, at a place and time announced with appropriate notice to all concerned. As SAMSO's only purpose is to assist the groups and districts in carrying the AA message, it is not involved in any decision making process outside of its own structural and policy issues that from time to time may arise. A simple majority, with the Right of Appeal in force, will decide issues. Each member of SAMSO in attendance will have one vote. A record of members in attendance will be maintained. Any motions presented to consider a change in the structure or policy of SAMSO will be voted on at the second meeting following the motion, after discussion for two months. An issue outside of SAMSO's usual business may be discussed after normal business is concluded and upon approval of SAMSO members present.

FUNDS

Funds for SAMSO will be provided by contributions from within the fellowship and may be earmarked by the contributor as to where the funds will be applied. In general, funds may be spent to assist in facilitating service committee work and to help defray costs for service committee chairs who attend the two SWTA workshops each year (non-voting assemblies in January and July). Funds will be for hotel and gas not to exceed \$150 per workshop, as SAMSO funds are available. Committees may engage in their own fundraising efforts, in accordance with AA Traditions, in order to fund their service efforts. Neither SAMSO nor any of its committees shall, beyond a prudent reserve, accumulate funds for anything other than a stated AA purpose, nor shall any expenditure be made that does not comply with the spirit of the AA Traditions.
