SPRING BRANCH NOON GROUP: When I think about “Home Group”, I focus on the word “Home”. It implies to me safety, comfort, refuge, family, warmth and love. I feel all that and more with my AA Home Group. On my first meeting at the Spring Branch Group I felt a sense of belonging. I was genuinely welcomed and encouraged to “keep coming back”. Having just been released from rehab, it was my first AA meeting in the real world, outside of a controlled facility. I was told in rehab to “shop” meetings. I didn’t venture very far because I found everything I wanted and needed in Spring Branch. It’s a relatively new group, having been formed less than 6 years ago by two couples, a coffee pot and 2 meetings a week. Now we have eleven open meetings a week with an average of twenty participants in each. Also in attendance are the strong forty-three years to forty-three hours. I’m always amazed at how many attend the 7am meeting (now 7 days a week). Some of us didn’t know what 7am looked like when we were still drinking! But what a great way to start a day...sober and sharing with other recovering alcoholics our experiences, strength and hope. We are a family, with each member serving a special purpose. We’re always eager to welcome another kindred spirit in our travels on the road of happy destiny.

I invite anyone to visit my Spring Branch Group at any meeting, 7 days a week. Look for the red door and behind it you’ll find a family group with responsible hands and loving hearts to reach out and share the message of Alcoholics Anonymous.

BROADWAY GROUP: I came into AA 1/27/73 and started with the Broadway Group in February 1973. We called it a “couples” group as most of us were married and our spouses were in Al-Anon. The meeting was from 8:15pm to 9:45pm. One of our members called himself “a reformed alcoholic”. Jack was in his 90’s and had stopped drinking before AA started. We were not really a “couple group”, but again most of us were married. We had lots of goodies after the meeting. We met in the back room. We had a base of 8 or more couples. We had been together a long time.

Most of the folks were over 40 and had at least 15 years of sobriety and more. We all wore suits or sports clothes. We had a chairman and co-chairman. We all smoked and usually took a break halfway thru the meeting so to let the smoke clear. We all shared AA & Al-Anon. Most of the folks who went to the meeting have passed on. I am not sure but believe I am one of a few who are still living from the beginning of the group.

The group changed from open to closed sometime in 1976 or 1977. This was a rough patch for the group. We lost our closeness. It went back to open but the group had a tough time there too. I left San Antonio in May 1978 and lost touch with the group. I come to visit whenever possible and health permits. I am grateful that the meeting was there in 1973 as it was a big part of my recovery.

To the Greater San Antonio Fellowship:

It is time for Lloyd and me to move on in our service to Alcoholics Anonymous. We have personally grown and benefitted from being your managers at the Central Service Office (CSO) for 9 years. As we try to reflect over the years, so many faces come to mind. What a journey it has been for the office. None of it would have happened without your support.

Together we started here at the end of 2002 with over \$12,000.00 in debt and not a Big Book in site. We were not so sure we could help do anything about the situation, and it was true. However, together, with the fellowship leading the way, we could and did. When you heard about our dilemma, so many of you rallied, and within weeks the debt was paid.

We will always remember our fellowship pulling together for the Katrina evacuees. GSO called to ask if they could help us with literature and we got to thank them; but our local fellowship was taking care of everyone with literature and meetings at all the shelters. Even our local newspaper announced that Alcoholics Anonymous was ready for the evacuees when they arrived in San Antonio.

The office has doubled in size providing attractive space for retail, storage to keep our groups stocked with literature, and even available meeting space for the fellowship. We have extended our service area to include districts 02, 01E, and 12. The implementation of Quick Books has made us more accountable to the fellowship. Our online meeting directory has made us more accessible to the newcomer looking for AA meetings.

We have a San Antonio history book (AA in SA) that will forever immortalize our beginnings. Thank you Bob for your perseverance with this project. The result was phenomenal.

We have to mention the 2010 International Convention that was held here in San Antonio. The Central Office was very involved and was responsible for the first book store managed by a Central Office at an International. We were in the middle of all the activities and planning done by our local host committee, and what a wonderful job our volunteers did welcoming the world to San Antonio.

You see, we get to watch God at work on a daily basis here at CSO. There were many volunteers that kept this deal working. There are some volunteers that are no longer with us, members that dedicated their service to the office. We will always remember that the office is still needed because of the many desperate calls for help; not only the alcoholic, but from hopeless family members reaching out. Lloyd and I loved being in the middle of it all, and it will surely be difficult to give that up December 31, 2011.

Thank you for the opportunity to make a difference. Thank you for your support, your trust, and your love. There are no words to describe our appreciation for the journey of a lifetime.

Our vision has been realized for the office. It is time for something and someone new.

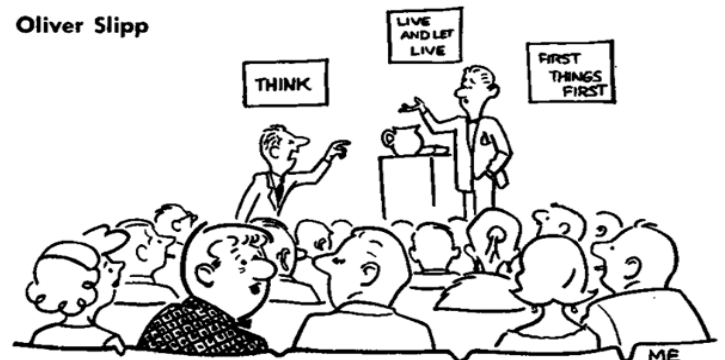
cont from page one—Manager's duties

3. Develops and maintains a recording system which supports all aspects of CSO Operations. Prepares and files all documents required by IRS or other government agencies.
4. Maintains operating checking account established by the Board. Pays accounts payable and payroll in timely manner. Has signature authority on accounts and within limits set by the Board of Trustees. Deposits and keeps records of all contributions, sales proceeds, interest and other revenues. Must set up checks and balance system for all contributions.
5. Prepares or verifies monthly and annual financial reports.
6. Maintains in satisfactory condition CSO property and equipment. Represents the office in tenant affairs with the landlord in order to maintain an orderly office environment.
7. Orders, inventories and maintains display and sale of literature and sobriety reminders within guidelines established by the Board of Trustees. Maintains vendor files and corresponds as necessary with vendors.
8. Oversees, publishes and distributes The Nightcap newsletter, insuring timely mailing. Maintains address files as required. Edits or supervises editing of final copy and release for publication within guidelines set by the Board of Trustees.
9. Maintains petty cash account. Insures that office is maintained in orderly and business-like manner.
10. Insures that telephone is manned at all times during business hours.
11. Maintains a permanent record of the actions of the Board of Trustees. Prepares reports as directed by the Board of Trustees.
12. Establishes and maintains a friendly and hospitable atmosphere for A.A. members and others who may purchase items, seek information or carry out A.A. committee activities.

Compensation:

1. Pay to be commensurate with experience and qualifications. Employment to begin with a 90 day training and probation period, as directed by the personnel procedures manual. Upon completion of the probation period, the Board may authorize an increase. Annual merit increases are directed in the personnel procedures manual and with board approval.
2. There are no personnel benefits associated with this employment.

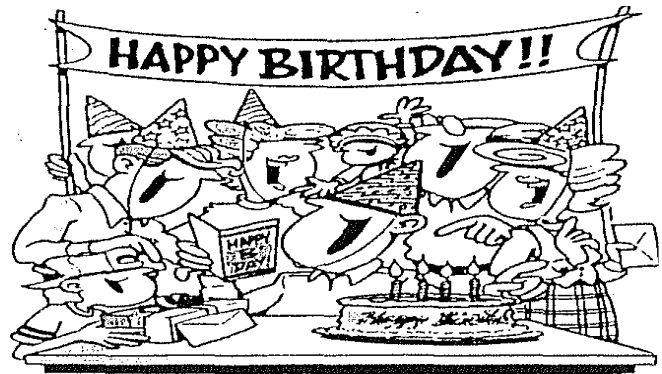
